

Mandatory Declarations Policy

AUSTRALIA AND NEW ZEALAND COLLEGE OF PERFUSIONISTS MANDATORY DECLARATIONS POLICY

Declarations are required by all perfusionists to show they agree to abide by the ANZCP Code of Ethical Practice and ANZCP of Professional Conduct and that they are "fit to practice".

All Perfusionists applying for initial Certification or Continuing Professional Development Recertification Membership must sign a declaration attesting to the following:

MANDATORY CPD DECLARATIONS

I declare that:

- I have practiced clinical perfusion as per the ANZCP CPD requirements for a minimum of 50 cases over the last 12 months and acquired 15 points for continuing professional development, OR I am participating in a Resumption of Accredited Practise program, OR I have graduated from the ABCP Perfusion Certificate Program within the last 12 months.
- I have read and understood the CPD Policy and agree to abide by the requirements of the CPD program. I will need to complete the CPD program requirements for this year to count as an active APD year.
- I have emailed or uploaded all my CPD forms to the Registration Board.
- If I request to defer my CPD status at any point during the upcoming year, I will need to complete the CPD program requirements before commencing the deferment for this year to count as an active CPD year.
- I am in professional good standing and no existing restrictions to practice in any country.
- I have no pending disciplinary actions domestically or internationally.
- I have read, understood and agree to abode by both the ANZCP Code of Ethical Practice and Code of Professional Conduct.

Please note that a false declaration may result in a review by the ANZCP Complaints Board*. If you have any questions, or cannot declare any of the statements above, please contact the Registrar of the Registration Board at registrar@anzcp.org.

*If you are selected for random audit, you will need to provide evidence of all your clinical and professional activity. For details of accepted forms of evidence, please see CPD Policy.



Assessment of Declarations:

Please contact the Registrar of the Registration Board at registrar@anzcp.org if you cannot make any of these declarations. A false declaration will result in review by the Complaints Board.

Any application requiring assessment will be considered by the Registrar of the Registration Board and the ANZCP President with final approval by the Executive Committee. Legal advice may be consulted regarding the assessment if required or the matter may be referred to the Complaints Board.

I declare.

- I have read and understood both the ANZCP Code of Ethical Practice and the ANZCP Code of Professional Conduct. I undertake to abide by these professional standards.
- I have not been convicted, nor currently facing charges in any court in Australia and New Zealand, or elsewhere, of any offence punishable by imprisonment for a term of 3 months or longer.
- I know of no information that could cause the Australian and New Zealand College of Perfusionists not be satisfied that I am fit to practice and am a competent person to be a certified member of ANZCP.
- All information I have provided is true and correct to the best of my knowledge.
- I agree to notify ANZCP if information relating to any of the above changes as soon as practical.
