Be an enthusiastic <u>Certificate in Cardiovascular Perfusion (CCP)</u> qualified perfusionist looking to join a small highly specialised team.

New graduates are welcome to apply – Paediatric training will be provided by our advanced perfusion leaders.

## Your Role and Responsibilities

You will fulfil the accountabilities of this role in accordance with the CHQ HHS core values and as outlined below.

#### **Clinical Practice**

- Deliver specialised clinical services within paediatric cardiac perfusion and the QCH ECLS
  (Extracorporeal Life Support) teams in accordance with the Australia and New Zealand College of
  Perfusion (ANZCP) and international best practice (ICEBP International Consortium of Evidence
  Based Perfusion).
- Identifying and assessing each patient prior to cardiac bypass surgery
- Applying specialised assessment to determine the most appropriate equipment and consumables as
  well as fluids including blood products and specialist drugs for each patient. Apply high level specialist
  expertise in the clinical practice of paediatric cardiac bypass.
- Apply professional judgement to each patient's complexity and requirements in paediatric cardiac perfusion
- Participates in an on-call roster which provides a 24 hr / 7 day a week on-call service and after-hours service where necessary
- Undertake the management of paediatric life support during periods of cardiopulmonary bypass (CPB) incorporating the management of patient temperature, biochemistry and blood gas chemistry and including, when necessary, the use of advanced techniques such as Deep Hypothermic Circulatory Arrest (DHCA), Antegrade Cerebral Perfusion (ACP), Vacuum Assisted Venous Drainage (VAVD), and Haemofiltration

## **Communication / Team Participation:**

- Provide clinical advice to Children's Health Queensland colleagues as well as colleagues from other Hospital and Health Services and state-wide on issues relating to paediatric cardiac perfusion, ECLS and auto transfusion, including clinical service development.
- Provide clinical direction and advice to medical and clinical colleagues within Children's Health
  Queensland, other Hospital and Health Services and state-wide on contemporary best practice and
  new technology trends relating to paediatric cardiac perfusion, ECLS and autotransfusion.

### **Leadership / Service Improvement:**

- Work with senior staff to ensure the maintenance of professional clinical standards within the Queensland Children's Hospital Paediatric Cardiac Perfusion Department and the QCH ECLS Service. This follows the regulations and clinical practice guidelines as well as protocols in place that are supported by the ANZCP.
- Contributes to the coordination of professional development activities across the Queensland Children's Paediatric Cardiac Perfusion department and the QCH ECLS service and state-wide, as required.

# **Qualifications/Professional Registration/Other Requirements**

- The successful applicant must hold an appropriate tertiary Science degree (or equivalent) and hold a
  current post graduate Certificate in Cardiovascular Perfusion (CCP) via the Australia and New Zealand
  Board of Cardiovascular Perfusion (ANZBP) or equivalent and be eligible for membership with The
  Australia and New Zealand College of Perfusion (ANZCP).
- Evidence of post graduate research work leading to a higher degree in science would be favourably considered.
- Appointment to this position requires proof of qualification. Certified copies of the required information must be provided to the appropriate supervisor/ manager, prior to the commencement of clinical duties.
- This position requires you to participate in an on call roster.

# How will you be assessed?

You will be assessed on your ability to demonstrate the following key attributes. Within the context of the 'Your Role and Responsibilities' described above; the ideal applicant will be someone who can demonstrate the following:

#### Clinical Practice

- Understanding of the conduct of whole-body perfusion and circulatory support including Extracorporeal Life Support (ECLS)
- Understanding of the working environment of cardiac surgery, including long, irregular hours plus a commitment to participate in an on-call roster for emergency cases.
- Ability to negotiate and communicate effectively, both verbally and in writing, with all levels of individuals and groups.
- Sound knowledge of contemporary human resource management issues including workplace health and safety issues, equal employment opportunity and anti-discrimination.

#### Communication

- Provide clear communication and demonstrate excellent teamwork skills.
- Initiate, assess and promote quality improvement, education, training, research, and development within Perfusion Services.

## Leadership Skills

The Paediatric Cardiac Perfusion service utilises novel highly specialised equipment and a high level of specialist expertise in the context of contemporary cardiopulmonary bypass (CPB) as well as extra corporeal life support (ECLS) and auto transfusion for paediatric cardiac patients in Queensland.

The Paediatric Cardiac Perfusion Service is also involved in research projects as well as contemporary international best practice and offers emergency on-call services for both paediatric cardiac perfusion and ECLS – this includes a paediatric ECLS retrieval service.
